For parents struggling to manage their child's diabetes, even seemingly benign interactions with health professionals can lead to feelings of judgement, criticism, and shame. Shame and perceived lack of support can contribute to management problems and poorer health outcomes. We aim to explore relationships between parents' perceptions of shame and autonomy support, diabetes management beliefs and behaviours, parenting experiences, and child health. This research will lead to improved care for children and families. This study will use a cross-sectional design. Information directing interested parents to contact the researchers about the study will be distributed to state and independent primary and secondary schools Australia-wide for inclusion in school newsletters. Potential participants will be directed to the study website to access detailed information about the study. The Study Information Sheet will be provided via the website, followed by the Study Consent Statement. Those wishing to participate will be directed to click the "Yes – I wish to participate" box at the end of the consent statement to proceed to the online survey.
